(2) Reasons for the changes

The current President, Mr. Toshiya Kobayashi, has been in office for eight years since June 2017. During this period, in order to accommodate for the expected increase in the number of Narita Airport users, he has worked to improve access to Narita Airport by significantly increasing the frequency of Skyliner trains to every 20 minutes throughout the day. In addition, despite the COVID-19 pandemic, which spread rapidly around the world, dealing a severe blow to the Company's business and leading to two consecutive years of losses through FY2021, the Company has achieved steady recovery and growth in the post-COVID-19 era by continuing to provide daily transportation services as a public transportation provider while implementing infection prevention measures and by making a concerted effort to prepare for what comes next without reducing its workforce or lowering wages. Furthermore, Mr. Toshiya Kobayashi has led the formulation of the Company's long-term management plan, the D Plan (covering the period from FY2022 to FY2030), and diligently promoted the first phase of the plan-i.e., the medium-term management plan: D1 Plan (covering the period from FY2022 to FY2024). In particular, he has achieved positive outcomes with respect to the goal of recovering from the COVID slump with a return to growth and laying the management promotion framework to achieve the Company's long-term vision by further improving the convenience of access to Narita Airport and expanding the business base of the real estate leasing business as the Company's second core business. In addition, with the aim of establishing a group management promotion framework for the next 100 years, he has implemented the Company's merger with Shin-Keisei Electric Railway Co., Ltd., reorganization of its bus and taxi businesses, and reorganization of its group businesses in Ibaraki Prefecture, among other activities.

The Company's performance is favorable and, in transitioning to a phase where the Company will realize the various measures established by the current President and take on challenges, the Company intends to achieve its mid-term management objective in the D2 Plan (covering the period from FY2025 to FY2027) starting this fiscal year, which is to "aim to promote the enhancement of airport access and strengthen resilience to external changes in order to realize the long-term vision under a new group management promotion framework." Therefore, the Company has decided to make changes regarding its Representative Directors in order to further strengthen its management structure.
